




- 1<sup>st</sup> wave of investment in Vietnam since 1980s, spanning most of the province an covering many industries and economic sector.

#### **DEFINITION**

Mark means any sign used to distinguish goods or services of different organizations or individuals

(Art.4.16 IP Law)

#### GENERAL CONDITIONS FOR MARKS ELIGIBLE FOR PROTECTION

A mark shall be protected when it satisfies the following conditions:

- 1. Visible sign (not including unconventional trademark)
- 2. Distinctivenes

(Art.74.1 IP Law)



-3D (holograms)














#### COMMON FORMS OF TRADEMARK

- -Trademark
- -Collective mark (used to distinguish goods or services of members from those of non-members of an organization which is the owner of such mark)
- -Certificate mark (means a mark which is authorized by its owner to be used by another organization or individual, for the purpose of certifying the origin, raw materials, materials, mode of manufacture of goods or manner of provision of services, quality, accuracy, safety or other characteristics of goods or services bearing the mark)


#### HOW TO CHOOSE AN APPROPRIATE SIGN TO BE A TRADEMARK



Inherent distinctivenese Art. 74.2. a), b), c), d) IP Law

- Simple shapes/geometric figures/numerals, letters or scripts of uncommon languages
- Conventional signs or symbols, pictures or common names in any language of goods
- Signs which is descriptive of goods
- Signs describing the legal status and business field of business entities;

Exception:
signs have
acquired
distinctiveness
through use

### Capability to distinguish from other signs

(Art. 74.2. dd), e), g), h), i), k), l), m), n) IP Law)

#### Signs can not be protected as trademark if



- Indicating the **geographical origin** of goods or services\*
- Conficting with registered trademark of another person
- Conficting with unregistered trademark of another person's mark which has been widely used and recognized for similar or identical goods or services before the filing date or the priority date
- Conficting with registered trademark of another person's mark, the registration certificate of which has been invalidated for no more than 5 years
- Conficting with unregistered/registered trademark of another person's mark which is recognized as a **well-known mark**

#### Capability to distinguish from other signs

(Art. 74.2. dd), e), g), h), i), k), l), m), n) IP Law)

### Signs can not be protected as trademark if

- conflicting with **trade name** currently in use if the use of such signs may cause confusion to consumers as to the origin of goods or services;
- conflicting with a **geographical indication** being protected if the use of such signs may mislead consumers as to the geographical origin of goods;
- conflicting with **another person's industrial design** which has been protected on the basis of an industrial design registration application with the filing date or priority date earlier than that of the mark registration application.
- conflicting with another person's copyright work


Not belong to the subjects which do not protected as trademark Art. 73, 8.1 (IP Law)

#### Signs can not be protected as trademark if

- ... objects which are contrary to national laws, social morality and public order or harmful to national defence and security.
- Signs identical with or confusingly similar to national flags or national emblems or emblems, flags, armorial bearings... of Vietnam or other country ...real names, alias, pseudonyms or images of leaders, national heroes or famous personalities of Vietnam or foreign countries;
- Signs which cause misleading or confusion or deceive consumers as to the origin, properties, intended utilities, quality, value or other characteristics of goods or services...





### Representation of a mark

- Clear (including corlor)
- Marks contain foreign must provide transliteration and translation





### List of goods/services

- Must be clear to specify the goods and services
- Multiple classes in one application is accepted
- NICE classification: Not member of Nice Agreement but follow it

#### **Power of Attorney**

- Can be in English but must translate in to Vietnamese
- Can reauthorize (more than one time) with the application's owner consent

### **Registration Rules**

- "First to file"
- Priority



#### Grounds for establishment of industrial property rights

- Registration system
- Exception: wellknown trademark (Industrial property rights to well-known marks shall be established on the basis of their actual public use that has made them well known, )



#### Grounds for establishment of industrial property rights

- Registration system
- Exception: wellknown trademark (Industrial property rights to well-known marks shall be established on the basis of their actual public use that has made them well known, )



### Term and scope of protection

- Term of protection: 10 years. This term may be extended successively every ten year via application for renewal

### - Scope of protection

- + In the whole teritory of Vietnam
- + According to the contents of the protection title







First class (no more than 6 products or services )	1.000.000
From the second class	730.000
The seventh products or service and more (each class)	150.000
Certiicate fee	120.000
From the second class (each class)	100.000
Classification fee (no more than 6 products or services)	100.000
From the seventh product or service (each product or service)	20.000
Opposition fee	550.000
Amendement application fee	160.000
Transfer application fee	160.000
Using protection title fee (1 class/10 years)	700.000

#### **OPPOSITION (Art.112 IP Law)**



### Withdrawal of industrial property registration applications

- When: Before final decision is issued (refusal or grant)
- Who: By applicant or through his representative (authorization document is required)
- How: written document
- Result: be considered having never been filed (exception of priority right claims)

#### Amendment, supplementation of application

- When: Before final decision is issued (refusal or grant)
- Conditions: must not expand the scope of the subject matter already disclosed or stated in such application and must not change the nature of the subject matter subject to registration stated in the application and must ensure the uniformity of the application.
- Fees and charges are required.

Art. 115 IP Law

#### **Division of application**

- Who: applicant by his-self or examiner's request
- When: Before final decision is issued (refusal or grant)
- How: written document
- Result: the filing date of the divided application shall be determined to be the filing date of the original application.

# 2. BASIC OF TRADEMARK PROTECTION IN VIETNAM Invalidation of protection titles

- > Who can apply for invalidation: any person
- > Type of invalidation: entire or partial
- > Reason for invalidation:
  - √The registration applicant has neither had nor been assigned the right to register a mark;
  - √The subject matter of industrial property fails to satisfy the protection conditions at the time the protection title is granted.
  - ✓ A protection title shall be partly invalidated when that part fails to satisfy the protection conditions.
- For marks, 5 years from the grant date, except where the protection title has been granted due to the applicant's dishonesty.
- Fees and charge are required
